

ED Insider License

ED Insider is a subscriber information service provided by Education Directions Ltd (ED) via a website at www.edinsider.co.nz, along with RSS feeds and email. It provides tertiary education professionals with strategic policy, industry and tertiary education sector information about their environment, supporting them to make effective strategic decisions.

By buying a subscription to this service, the Subscriber agrees to abide by this license. Clauses 1-12 below also apply to free trial subscriptions, with the Subscriber in Schedule 1 being the individual signing up for the trial, and the subscription period being that granted by ED at the time of the trial starting.

1. **Parties, price and subscription period** – see schedule 1.
2. **Coverage** – Service coverage and content will vary from time to time at the discretion of ED, within the overall aim of giving tertiary education professionals the strategic policy, industry and tertiary education sector information they need about their environment. The current coverage will be displayed on the *ED Insider* website.
3. **Authorised users** – Up to 10 nominated staff of the Subscriber will be given a login and password for *ED Insider* and be eligible to receive material via RSS feeds or email – additional users may be added at ED’s discretion. Authorised users are added by ED upon request. Members of governing bodies may be added to the distribution list at the discretion of ED, but such additions will be unlikely for national tertiary education sector groups, other than for the chairperson. Website username and password information, and RSS feed keys must not be passed on to people who are not authorised users.
4. **Authorised uses** – Information on the *ED Insider* website can be viewed, searched, downloaded and printed, subject to New Zealand copyright laws. Subscribers can receive information feeds from the website. Subscribers can add comment to the website. Contact ED if you need clarification.
5. **Limits to use** – Information may be distributed to any person on the staff or governing body (except for national tertiary education bodies) of the Subscriber, but not to any external party unless there is specific approval from ED. Contact ED if you need clarification.
6. **Comments** - All comment on the site is subject to moderation and should aim to be constructive. Comments with personal attacks or offensive language will not be accepted.
7. **Derived works** - Any works derived from *ED Insider* content must comply with New Zealand copyright law, this license and acknowledge *ED Insider* as the source. Such works must be for the internal business of the subscriber organisation and not for any other gain or commercial use.
8. **Copyright** - All data in *ED Insider* is owned by ED (or third party suppliers) and is subject to New Zealand copyright laws. If wider use is required, contact ED for approval. Written permission may be provided on a case by case basis.
9. **Information sources** - *ED Insider* undertakes to source quality information from reliable sources. Should ED be informed of any factual errors in content, these will be amended promptly. ED accepts no responsibility for any third party material included in this service.
10. **Information technology** – ED undertakes to make use of effective and reliable technology to deliver *ED Insider*. However ED accepts no responsibility for delivery delays or problems caused by technology issues outside its control.
11. **Independent Advice** – While ED takes every care to provide quality advice, subscribers should seek their own advice and make their own analysis before making business decisions upon matters covered by *ED Insider*. ED accepts no liability for those decisions.
